Children's Care, Learning and Development Professional Practice

This is an advanced level qualification aimed at professional Child Care workers and is designed for individuals employed within the Early Years and Childcare sector. Learners undertaking this course will need to be in a senior position or if a child minder, the ability to demonstrate support of others with less experience. You will also need to hold a Level 3 CCPLD qualification and be over 19.

The course is knowledge based, learners can complete the Level 4 qualification before they have attained a Management role.

Welsh Government is committed to raising the levels of Essential Skills across Wales. Communication, Digital Literacy and Application of Number qualifications are an integral element of the funded apprenticeship frameworks.

These are usually delivered through workshops at one of our centres and will be planned well in advance. If you have completed Essential Skills previously or are able to provide suitable evidence, such as GCSE certificates or similar, you may be exempt from completing this element of the qualification.

Qualification Overview

To achieve the Level 4 Professional Practice in Children's Care, Play, Learning and Development qualification, learners must achieve a minimum of **60 credits in total**.

To achieve the qualification learners must take one of the following three pathways:

- Working with families and carers to develop parenting skills
- Working with children with Speech, Language and Communication Needs (SLCN)
- Recognising and supporting children with Additional Learning Needs (ALN)

To achieve the Level 4 Professional Practice in Children's Care, Play, Learning and Development (Working with families and carers to develop parenting skills) learners must achieve a minimum of 64 credits from the Mandatory group

Please note that:

- Monthly tutor visits are required and extra visits or support can be provided if needed
- Tutor sessions may last up to two hours, and can be face to face at your work setting or remote visits using online platforms
- The qualification will take 24 months to complete
